

Per the Policy on Harassment at the University of Tulsa Section J, Duty to Act, I wish to file a formal complaint against George Trey Barnett for repeated acts that have been humiliating, demeaning and damaging to the reputations of two faculty (Kimberly Powers and Machele Dill) and a student theatre major [REDACTED] – and also damaging to their morale and relationships with others.

I have two postings, claimed by Trey to have been written by Chris Mangum, Trey's partner, posted under the name Chris Blackstone, with Chris' picture attached – posted to Trey's personal Facebook page last spring in March when Trey was in Ireland. These postings falsely accused Machele Dill and personally attached [REDACTED]. I have another posting, supposedly written by Chris under the same last name "Blackstone" attacking Kimberly Powers late last spring in April during a community service project that she directed at Ziegler Art & Frame for Kendall Whittier. On the same page below this posting, a [REDACTED] wrote, "you realize that you can send personal messages to people. Lol" Chris'/Trey's response was "Yeah but I Didn't Want that to be a personal message. They are idiots." Another posting was made on the KTUL website concerning the Kendall Whittier project under the name "John" around the same time. I believe Trey and/or Chris wrote this posting attacking Kimberly Powers because it uses the same language and same accusations as the March postings from Ireland. The latest attacks began last weekend on a website called TU Confessions, attacking Kimberly Powers and [REDACTED] about incidents involving Trey in the TU production, *The Glass Menagerie*.

In all postings Trey has been the common factor. He was present in Ireland, he was part of the Kendall Whittier project at Ziegler's, and he was the Lighting Designer for *The Glass Menagerie*. These postings contain vicious personal attacks and specific details of events involving Trey. It is claimed that Chris is the author, but the accusations are all against faculty and students involved with Trey in various incidents.

When I was notified about the TU Confessions post early Sunday morning, I contacted Trey immediately and urged him to stop this latest attack. During our conversation, I inadvertently informed him that the posting was no longer on the TU Confessions Website. Thirty-eight minutes after I finished speaking with Trey, I was shocked to find the TU Confessions posting now up on Trey's personal Facebook page with the comment, "we were both surprised it was taken down." The "we" makes it clear that Trey and Chris are working together.

I spoke with Trey by phone as soon as I was aware of the attacks from Ireland urging him to take the postings down and in person again when he returned to Tulsa from Ireland. In both instances, I warned him that these kinds of derogatory public attacks must cease. I spoke with Trey, following the Kendal Whittier posting urging him to take down it down and again warned him to cease all forms of this activity. Looking back, I guess he never really took my warnings seriously.

Trey seems to think that, as long as he can claim, "Chris did it," he can hide behind Chris and avoid responsibility for these attacks on our faculty and students. The only reason I can think of

for posting these attacks is to make sure that Theatre faculty and students receive their "message." The message has been received loud and clear; these attacks have had their desired effect. Morale and relationships in our Department have been harmed. These postings have damaged reputations; undermined and disrupted the faculty's ability to offer academic programs and co-curricular activities. These attacks have disrupted other students as well as Ms. [REDACTED] right to participate without fear, in class, on productions, and in co-curricular activities in our Theatre Department and for the College.

Screen Shot of KTUL Website Arpil 4-28, 2014 8:30pm



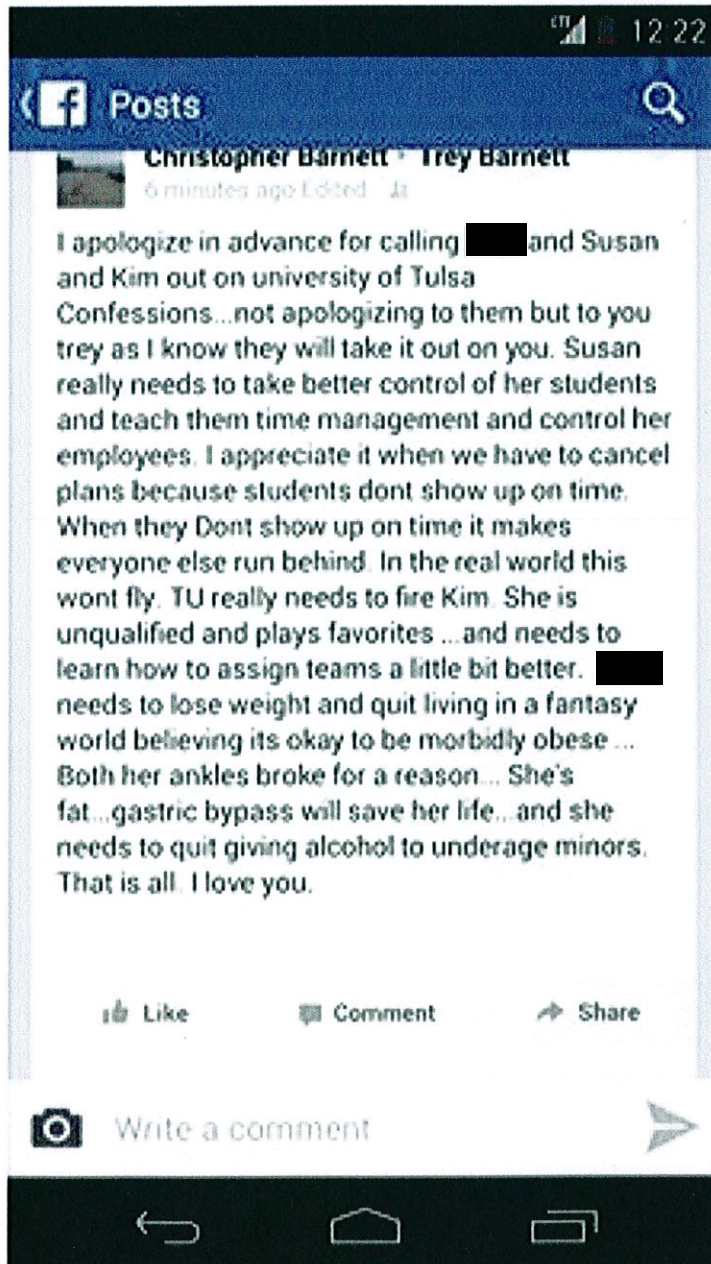

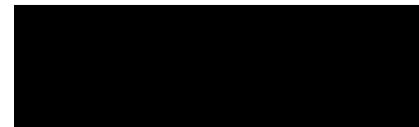
